STALL SITES

- Stalls must not be pulled down prior to 9.00 pm Friday & 4.00pm Saturday. (if sold out stalls can be tied up/closed ready for pull down).
- Stallholders are to present stands and staffing to a high standard. It is the responsibility of the
- Stallholder to ensure marquees are securely weighted.
- Stallholders/Vendors are responsible for the disposal of all waste materials in an appropriate
- manner. All packaging and product waste is to be removed from the site by stallholder.
- Stallholders are required to supply their own lighting - indoor sites will be lit by the existing hall lights.
- Vehicle access:
 - Bump in - Friday - Any time up till 3.30 pm All vehicles must be clear of site by 3.30 pm
 - Bump out- Saturday - After 4.30pm.
- A copy of current public liability/product liability and all appropriate food licences must accompany all application forms.
- Wherever possible, preference will be given to stallholders from the local region, providing they meet all the application criteria.
- The A & H Society reserves the right to refuse any stall booking. No correspondence will be entered into.
- Sites will be allocated by the Stall Site Co-ordinator. Stall holders MUST use the stall site allocated to them. Site locations will not be amended.
- Food outlets have priority locations for electricity and water.
- The Mt Gambier A & H Show Society will hold a COVID Safety Plan. COVID Marshalls will be on site throughout the event.

CANCELLATIONS

- All cancellations must be received in writing
- Cancellations received prior to November 15th will attract a refund less administration fee, \$10.00
- Cancellations after November 15th will result in nil refund.
